### 1. Criteria to be eligible to hire

1.1 The final determination lies with the Redhead Surf Lifesaving Club Committee and/or its so designated members. The allocation will be conducted on a first served basis with the underlying principle that active competitors will have the highest priority. Hire for personal use and fitness will only be available if sufficient boards are available.

1.2 The individual wanting to hire a board for the season must be a full financial member of the club in their age or category.

1.3 The individual must have successfully completed and passed the water proficiency test both in the pool and in the surf.

1.4 Will have use of the nominated board (selected by the committee from the club's stock) for one season only.

1.5 Must use padded protective cover for the glass boards if provided by Redhead SLSC

1.6 Nippers are expected to bring and use their allocated board at all training sessions, carnivals and Club Sundays

1.7 The Parent/Guardian is responsible for transportation of the board to and from all training, carnivals and Club Sundays unless otherwise stated

1.8 Return the board to the club at the completion of the current season no later than presentation day. If the board is not returned by this date, your held credit card will be charged for the full current market replacement cost of the equivalent Kracka surfcraft.

### 2. Conditions of Use

2.1 All boards remain the property of Redhead SLSC

2.2 The boards must be maintained in good condition.

2.3 In the event you lose the loan board you will be responsible for the full replacement cost as at new purchase price from Kracka Surfcraft

2.4 It is recommended that boards not be strapped on top of each other, nor should they be left inside the car for long periods.

2.5 A club member will relinquish the rights to their allocated board (automatically lose their equipment allocation):

2.5.1 If the club member does not compete in 75% of club nominated board training sessions and surf carnivals including Branch and State titles. This will be monitored on a monthly basis.

2.5.2 If the club member retires from competition.

2.5.3 If a club member wilfully contributes to the destruction of the equipment.

2.5.4 If the committee considers there to be improper use of the loan board.

2.5.5 If the club member rides the board standing up which is dangerous to other surfers and the club members

2.5.6 If the club member does not adequately maintain the board or have repaired as necessary.

### 3. Repairs

3.1 In the event of damage to the Board, please notify the Junior Activities Gear Steward immediately so repair arrangements can be approved

3.2 No repairs are to be carried out by parent/guardian. Repairs must be completed by a Club approved repairer

3.3 All repairs and associated costs are the responsibility of the Parent/Guardian

3.4 Upon return of the board at the end of season, any additional repair costs above the bond amount will be charged to the parent's held credit card. These amounts will be discussed with the parent/guardian prior to repairs being undertaken.
